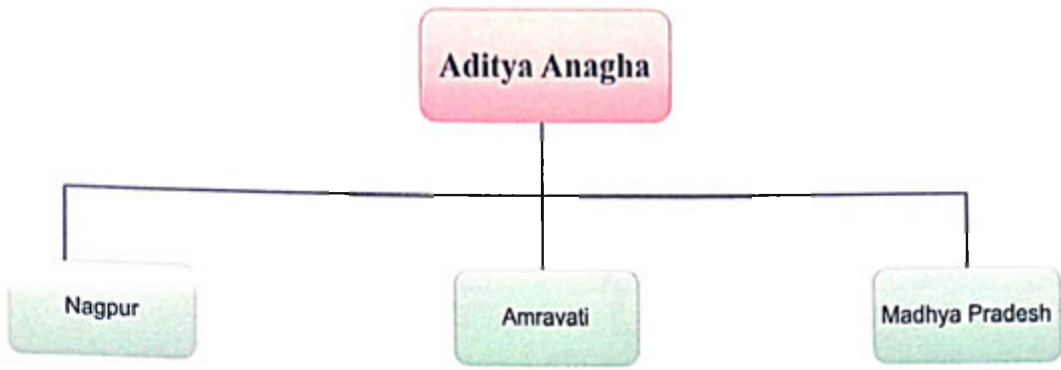

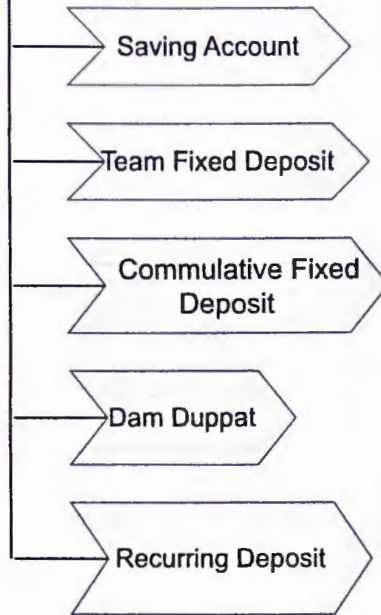

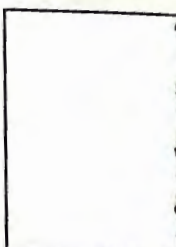

Term Fixed Deposits

A term Deposit is often used when the deposit is extended for a certain period say 3 months, 6 months etc. Fixed deposits on the other hand are often used when the deposit is for a period of 6 months or greater than that. 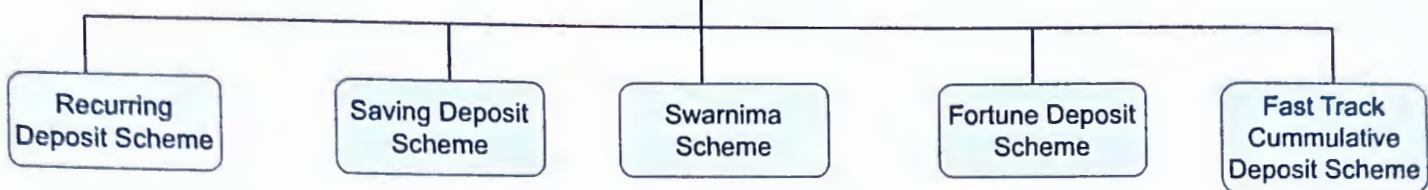

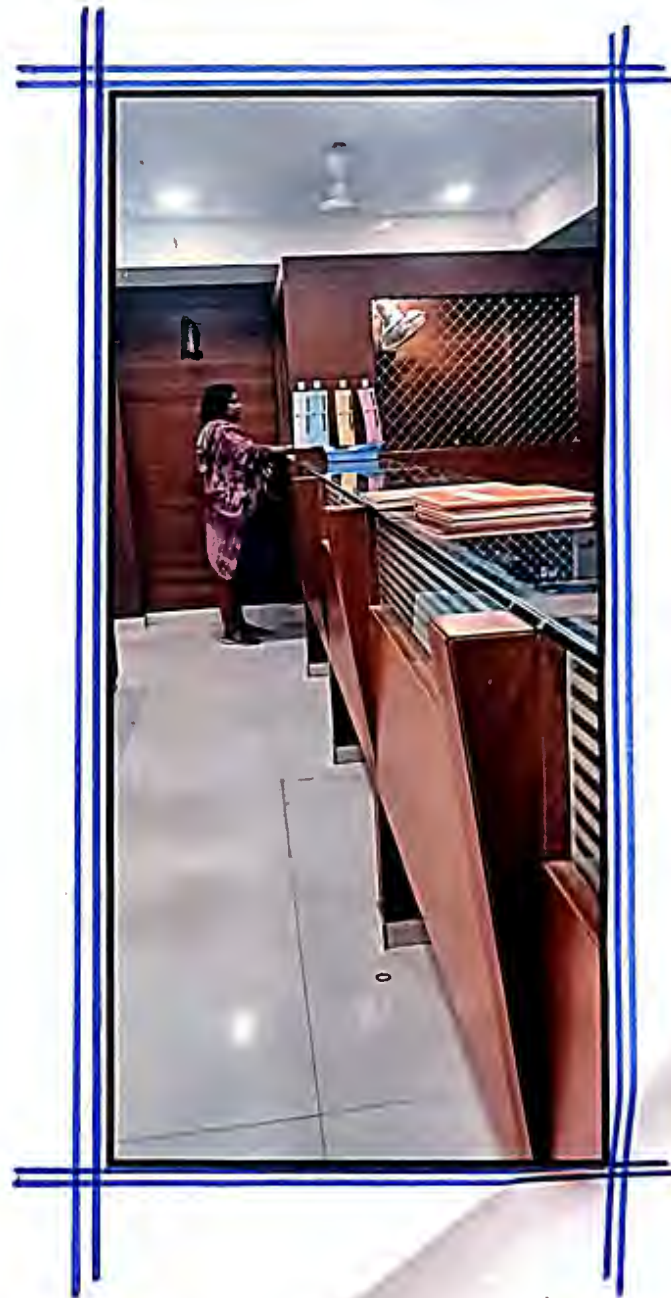

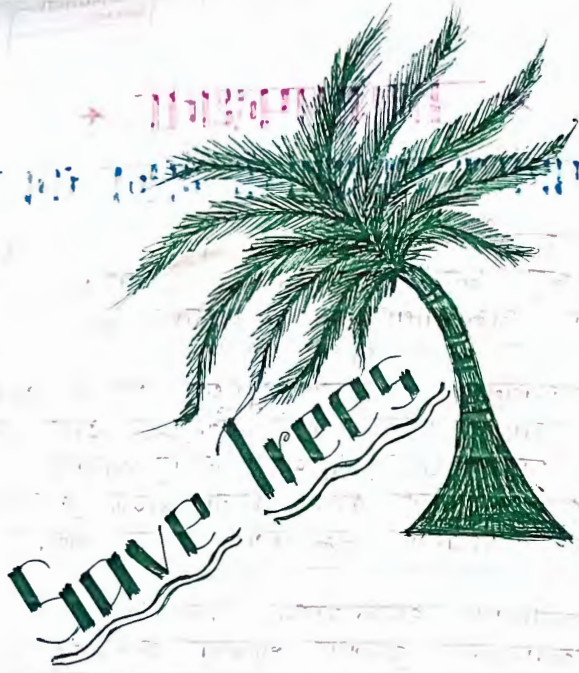
